GENERAL CONDITIONS

This contract, which includes the Practical Guide issued to competitors, is subject to French law. Any litigation arising from this contract, should it be impossible to find an out-of-court settlement, will be heard by the Commerce Tribunal in Paris. VAs far as the competitor is concerned, the technical organiser is the only holder of the filming rights, the moving images and sound recordings of the AFRICA ECO RACE. « AFRICA RACE », « AFRICA ECO RACE » and « DESERTS AVENTURES » are registered names, which have been registered with the National Institute of Industrial Property (Institut National de la Propriété Industrielle).

SARL Déserts Aventures is the authorised representative of the Organisation of Competitions and Tourism (OCT for short), SARL (R.C. Nouakchott n° 1585), designated as the technical organiser by the sporting associations of the federal authorities, to organise the race according to the regulations in force. Should there be a change of technical organiser, this contract will be continued with the newly designated organiser without interruption. Should the race be cancelled, for any reason whatsoever, the responsibility of the organisers is limited to the repayment of any deposit paid by the competitor to the organisers. Should the competitor cancel his participation for any reason whatsoever, any sum already paid by the competitor to the organiser will be retained by the organisers. In order to be taken into consideration, your entry request must be signed with the words 'read and approved' and must be accompanied by the minimum pre-entry fee of 1,200 euros per person and 1,000 euros per car. Your entry will only be definitive once the full entry fee has been received. It must be accompanied by this form, fully completed, the guarantee cheque of 1,300 euros and a passport photo per person (with the name clearly marked on the back) as well as copies of your passport, driving license and registration and insurance documents of your car.

We undertake that we are solely responsible for the validity of the various administrative documents which are needed in order to take part in the AFRICA ECO RACE 2010 in Spain, Morocco, Mauritania and Senegal.

In case of differences of interpretation, the French version of these documents will be considered as definitive and binding
